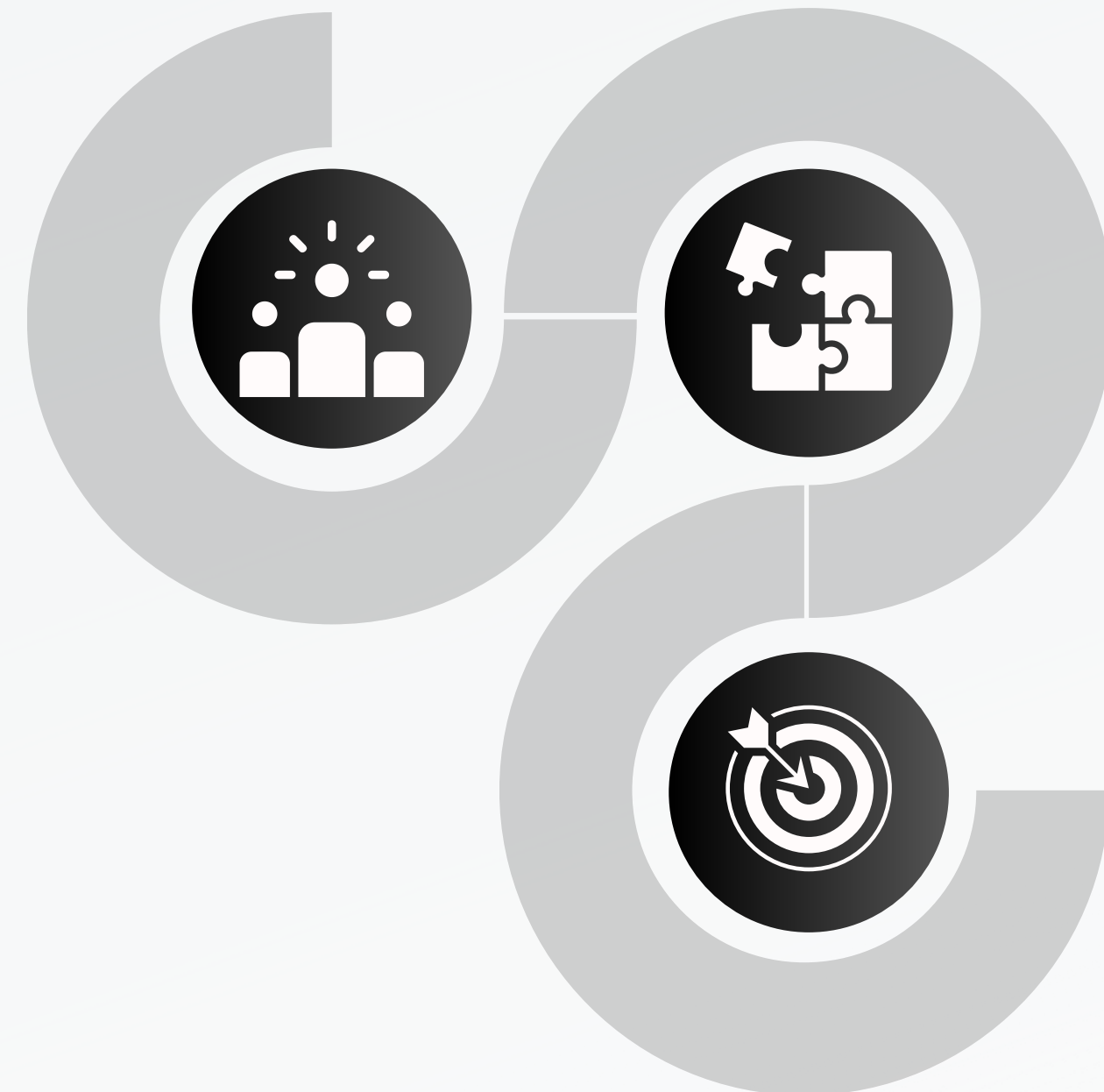

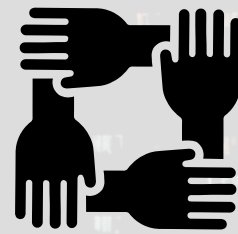
**Preventing Fraud and Corruption:** Aims to assist organizations in safeguarding their operations, processes, and culture.

# PRIMARY OBJECTIVES OF CACE



## Competency Assessment

Evaluate and measure the relevant competencies in preventing corruption among board members, senior management, and employees.



## Assessment

Identify strengths and weaknesses in the organization's anti-corruption knowledge needed to prevent fraud and corruption.



## Remediation

Choose appropriate measures to address identified weaknesses in anti-corruption knowledge.

## Management Representation Letter

This is a prerequisite to proceed with the certification process.

## CACE Review Program

Attendance of a required two-day CACE review program for four hours daily.

## CACE (CPMT) Certificate and Reports

This certificate is valid for one fiscal year. It is an integral part of this certificate. A report will be qualified when a board member or decision maker does not sit for the CPMT test.



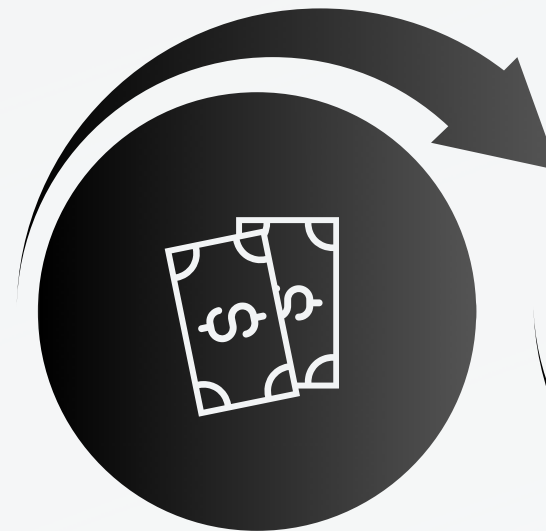
### Certification Contract

An organization contracts with the approved vendor of The AACI in its country, or region, or the Exam Unit.



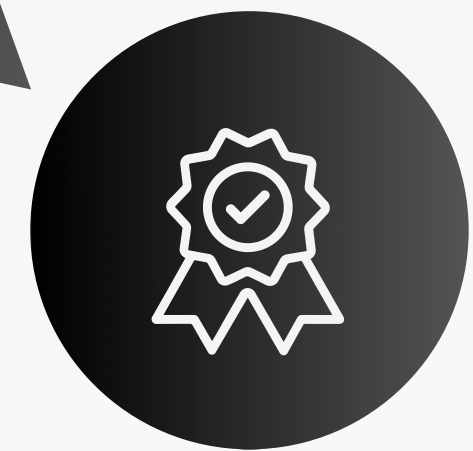
### Certification Fee

An organization should pay the certification fee

# CACE REVIEW COURSE PROGRAM

"Prepare decision-makers through a comprehensive two-day CACE review program, leveraging expert-led sessions and carefully selected materials, culminating in the CACE (CPMT) certification exam by December 15."

## Two - Day Review



An AACI-approved expert shall deliver via Zoom a required two-day CACE review program for four hours daily.

## Textbook and Materials



The CACF textbook is the primary reference for the CACE review course. Additional CACE materials shall also be used and delivered in the CACE review course program.

## CACE (CPMT) Exam




The entity's qualified decision makers shall sit for the Corruption Prevention Management Test (CPMT), the CACE certification exam. The CPMT is an in-person, proctored online exam.
